Finance Update	The budget documentation presented is from planning 2023. Budget becomes operational on March 28th. Figures are only confirmed when roll over occurs. Salaries are the largest part of the budget. Curriculum budgets are the largest areas of cash budget expenditure. Maintenance – DoE will pay for building maintenance. Schools must spend 96% of their budget within the school year. DoE gives one 'bucket of money' this is called the Student Centred Funding Model – the school then puts into curriculum budgets as per school planning. Budgetary considerations and resource allocations are done so to best meet the needs of the students. Cash budget has been prepared and reviewed by the School Finance Committee.
